What is the deadline for abstract submissions?

AMWC Americas: Submission deadline: September 29, 2023 Vegas Cosmetic Surgery: Submission deadline: November 27, 2023 The Aesthetic Show: Submission deadline: December 15, 2023

How can I submit my abstract?

To submit an abstract, please visit the <u>submission website</u>, and create an account. Follow the instructions provided and be sure to fill out all required fields and forms. Please whitelist/add the domain name @gocadmium.com to your Safe Senders List to ensure you receive emails.

Can I revise/edit my abstract after it has been submitted?

You can log back into your account and make changes to your abstract until it enters the review process. Once your submission is marked for review, you cannot make any changes.

How do I know my abstract has been received?

You will receive an automated email when you have submitted your abstract. This will include instructions for how to edit your abstract until the abstract deadline. Please whitelist/add the domain name @gocadmium.com to your Safe Senders List to ensure you receive emails.

Please note, incomplete submissions will be rejected and not submitted for review. If you do not receive an email with a notification that your completed abstract was received, please log back into your account to include all requested

information.

Is there an abstract submission fee?

There is no fee to submit an abstract.

Is there a limit to the number of abstracts I can submit?

There is a limit of 5 abstracts per Submitter and per parent company.

What should I do if I would like to withdraw my abstract?

If you wish to withdraw your abstract, a written request must be submitted to <u>cristina.cotto@informa.com</u> prior to the submission closing dates.

Who will be reviewing my submission(s)?

Each conference has its own Scientific Advisory Board (SAB). These SAB members are grouped into abstract review committees by subject matter expertise and review each abstract within a given category for their respective conference. They will rate it on a scale of 1 - 5, and they are asked to provide written insight on the quality, relevancy and value of the proposal. Once the advisory board completes their reviews, the content team will review all proposals and reviews to determine a balanced program.

When and how will I receive notification about the status of my abstract?

Notification regarding acceptance or denial of abstracts will be sent by email to the primary submitter no later than mid-December 2023.

Will you accept submissions by email?

Abstracts must be submitted online via the <u>submission website</u> only. ABSTRACTS SUBMITTED BY E-MAIL WILL NOT BE ACCEPTED.

Will you accept late breaking abstracts?

In some instances, we will reopen the submission portal for late breaking abstracts. Look out for an email announcement with information.

Will I be able to present virtually at the Conference?

No, all conferences will be in-person only. If you are unable to attend in person, you may submit presentations as Bonus Content for the program. These are pre-recorded presentations (PowerPoint slides with video/audio narration) and will be available for attendees to view on the Mobile App and a dedicated website for up to a year after the event.
